2023 Lobby Day

I believe that the 19 fair representatives who met with our legislators and state officials will agree that our Lobby Day efforts were successful and well received. It was really good to be able to get back to meeting in person. We met with 16 legislators on the schedule and some of us went to see an additional 8 or 10 to give them our information.

The \$500,000 for premiums appear to be safely within the Governor's budget. A legislative bill to lower the \$5,000 threshold to \$2,000 has been submitted by Assembly member Carrie Woerner in the Assembly and I understand, a similar bill will be introduced by Senator Michelle Hinchey in the Senate. I know the Assembly Bill has been moved into committee for consideration. We had a very positive meeting with Kevin King, Deputy Secretary for Food and Agriculture, from the Governor's office with a surprise appearance of Commissioner Richard Ball. This led to a very frank discussion about how difficult it is to get approval from the staff at Ag. & Markets to receive the Grant funds. We also discussed the promotion dollars of up to \$50,000 per fair. However, we're waiting on particulars on how they will be made available. The track record of Ag & Markets for making this sort of funding readily available to the fairs isn't great, so it's unlikely they will be much help this year. We can only hope. We had asked the legislators to include an additional \$25,000 for premium dollars in each of their one house budgets. The bad news is that neither included the additional \$25,000, but the good news is that they each did include another \$5,000,000 for capitol projects. The scope of this Grant seems to cover a wide range of projects. Hopefully, assuming money stays in the approved budget, more of our fairs will be able to take advantage of this Grant. At the time of this writing we're at least 2 weeks away from the state budget being in place. Assuming there's not a major fight over the big ticket items, we should come out of this okay.

I'm optimistic that Joe Ganley will help get the process moving. As you know it certainly has been a struggle. My source within the comptrollers office assures me that none of the Grant contracts have remained in that office longer than 15 days. Obviously they are not the problem. Once the "hoorah" over the budget is over I will contact our Reps to see what the status of the bill is. Thank you to Renee St Jacques and Maureen Bartczak at Farm Bureau for so much help setting up our meetings with so many influential people. Also thank you to all who participated and helped tell our story.

NYSAAF Ag Awareness Report

Committee Chair: Renée St. Jacques

Most eligible fairs for this year's Ag Awareness program have submitted applications. Thank you to the Ag Awareness Committee for reviewing these applications. Here is a list of projects that have been approved for this year so far:

Chautauqua County Fair- purchase gates for a travel path for cows to milking parlor so that they have easier access and install hose bibs in the wash racks to eliminate leakage when washing cows.

Columbia County Fair- design signs that detail various agricultural facts and information including the difference between dairy and beef cows.

Fonda Fair- purchase new pens for goats, sheep and hogs so that more livestock can be brought to the fair which adds to the agricultural educational experience for fairgoers.

Gouverneur & St. Lawrence County Fair- purchase barn fans for the show ring to run during livestock shows to help with the comfort of livestock during hot temperatures.

Livingston County Agricultural Society and Fair at Caledonia- create new food and agriculture display with raised garden beds. Local students will grow the vegetable plants in small pots at school and then the plants will be put in the raised garden beds at the fair. Creates an opportunity for youth to learn about growing food, but also adds an educational display about food agriculture at the fair.

Long Island Fair- add four TV monitors and educational signage to displays at the "Farmer for a Day" barn where there are interactive learning areas for youth to learn about chickens, potatoes, apples and dairy.

Niagara County Fair- purchase movable bleachers to use during fair that will provide seating for fairgoers watching the youth livestock shows

Ontario County Fair- purchase barn fans for the show ring to run during livestock shows to help with the comfort of livestock and fairgoers during hot temperatures.

Orange County Agriculture & Family Festival- create a 4-H Food System and Farm-to-Table educational display where fairgoers can learn how food is grown and processed.

Steuben County Fair- install sound system in cattle barn to keep exhibitors and visitors better informed on show schedule and other information between shows.

Warren County Youth Fair- purchase portable hand-washing station to set up near animals that are being displayed for educational purposes. Also, develop a display with an outline of the county and each township within the county. This display will be adaptable to feature different aspects of agriculture, such as locations of farmers markets and farm stands.

Wayne County Fair- create interactive agricultural informational posters, banners and displays to set up throughout the livestock exhibits



Scholarships!

April is here which means that the deadline for scholarship applications is too! If you haven't already, please send the NYSAAF/NYSSA scholarship information out to your local high schools, 4-H clubs/CCE Offices, or other youth connected to your fair. These are the future leaders in our industry, let's support them as best we can! There are up to 10, \$1500 Scholarships and a \$500 Fair Manager's Association Scholarship available. Applications must be received by the second Friday in April.

Applications must be received by the member fair or NYSSA by the 2nd Friday in April. Each application must be signed by a fair or NYSSA officer and must contain a written endorsement from the fair or NYSSA stating that the applicant was an active participant in your fair or outdoor amusement business. The more information you provide in this area, the easier it will be for the Scholarship Committee to review the applications. Selected applications must be sent to your District Director by the 3rd Friday in April.

Reminder: If you know a youth that applied last year and didn't receive a scholarship, encourage them to apply again as the field was quite competitive.
