

## **RULES FOR NOMINATION OF THE NYSAAF LIFETIME ACHIEVEMENT AWARD**

The NYSAAF Lifetime Achievement Award, presented during the annual NYSAAF Convention, recognizes individuals who have made a significant contribution to a NYSAAF member fair through years of invaluable service, dedication, and commitment.

### **ELIGIBILITY**

The conditions of eligibility are as follows:

- The nominee must be living.
- The nominee shall have served as a Director, Officer, Volunteer, Staff Member, Friend of a Fair, or Manager of a NYSAAF member Fair.
- The nominee must have shown consistent and significant service to a NYSAAF member fair.
- In addition to the person submitting the nomination, the candidate must be nominated by one NYSAAF member Fair representative or one NYSAAF Associate member.

### **NOMINATIONS**

The procedure to be followed by the Awards Committee in the selection of a candidate shall be as follows:

- Each year, the Awards Committee shall announce that the nominations are being received for a period prior to the annual Convention. Nominations must be received by December 1<sup>st</sup> of that year. A nomination form will be available on the NYSAAF website.
- Nominations for the award should be submitted with a record of the nominees' achievements in the fair industry and local community in sufficient detail so that a committee can pass judgment on the candidate's worthiness to receive the award. Also, be sure to include a biography of the person being nominated for use in the presentation. This record of achievement should be prepared by a representative of a NYSAAF member fair with one additional member Fair or one additional Associate member named as references.
- The awards committee will be made up of the Chairman, Executive Secretary, 2nd Vice President, 3rd Vice President, and immediate past winner. It will be the prerogative of the President of the NYSAAF to name additional members to the selection committee. All nominations will be forwarded to and results tabulated by the Executive Secretary of the NYSAAF.
- All questions coming before the Awards Committee shall be decided by a majority vote of the Committee. The Awards Committee shall have the power to decide any questions not specifically covered by these rules. The committee will make the final decision if an application is worthy of the award.
- The applications for nomination must be submitted annually. They will not be kept on file for future consideration.
